Cefndir / Background	

As a statutory public body, a Welsh Government Sponsored Body (WGSB), Llais is required to publish Annual Accounts and an Annual Report.

While Annual Accounts and an Annual Report for 2022/23 were limited, covering the establishment phase in the development of Llais, the more comprehensive Annual Accounts and Annual Report for 2023/24 reflects the full activities, performance, and governance of Llais, as an established and operational organisation.

Manylion / Detail

The Audit, Risk and Assurance Committee (ARAC) on behalf of the Board has:

- Considered the legislation setting out the Annual Accounts, Annual Report, and auditing requirements
- discussed the initial draft Annual Report and Accounts 2023/24 as presented at a meeting on 19 June 2024
- further considered the developing documentation at a meeting on the 20 August 2024, where the committee endorsed the submission of the Draft Annual Report and Accounts 2023/24 to meet the legislation set deadline of 31 August 2024. The submission was made to Auditor General for Wales and Welsh Ministers
- actively commented on the documentation between meetings
- held a further meeting on the 27 November 2024, where the feedback from the audit undertaken by Audit Wales was received and the committee



agreed to recommend to the Board the approval of the Llais Annual Report and Accounts for 2023/2024.

The draft Annual Report and Accounts presented to the Board for approval and adoption contain:

 - Statement of Financial Position (the balance sheet)
 - Statement of Cash Flows
 - Statement of Changes in Taxpayer's Equity
 - Notes to the accounts

The Audit, Risk and Assurance Committee also received an overview and considered the Audit Wales Audit of Accounts Report (including ISA 260), which is presented separately to the Board. Please note that the Letter of Representation from Llais to Audit Wales is included in Appendix 2 of the Audit of Accounts Report.
